This is simply to memorialize what has gone on... in case I drove off the road on the way back to the Vass Carthage dwelling. After finding out about all the lies with Arthur's Leave and Earnings Statement... which was a few days ago, yesterday I had an intuition about the home in Winston Salem... that something was not right

I drove up here, this house is fully furnished, with thousands of dollars of furniture that I have never seen and did not know we had purchased. There is a dining room set, a bedroom set, a leather couch end tables, lamps a huge samsung tv... turns out Arthur has Cable... Turner Cable. Arthur had promised me that he would not make major purchases without my consent and that he would not hide assets

Turns out that Arthur has been being paid under the table by Chuck... who owns the Urgent Care/ RAPID CARE in Sanford that Arthur works at through a company called Physicians Solutions. Arthur says he received \$600 Saturday under the table from Chuck. Arthur said he has a RCB account that does not have my name on it (I might have the name of the bank wrong, it is the same bank as E2 uses, there is a branch in Carthage). I knew nothing about this account. Arthur admitted that he used the account purchase the BIG screen TV and other things he will not discuss. It has a balance of at least \$1,000 or more. Arthur has a card from that bank.

I had to postpone my dental work, on an infected root canal because we did not have \$700 for the dentist. We owe Pete \$700 for hay... we owe a balance to our dog handler Kelly Marquis of over \$800 and we still owe Tommy Loving \$1,000 for hay we used in the fall of 2007. We owe other people as well. Arthur has the biggest TV I have ever seen, and a \$253 overdue cable bill. He just Thursday ordered some football tail gate stuff, a musical beer can opener (I guess he has a party to go to), and a bunch of dog stuff for the two dogs he has up here, one of whom is not ours.

This is also really sweet, tonight, when he got off work Arthur called me and told me that he was out of fuel for the truck and that the Wachovia account was empty... and he cursed at me that it was my fault that it was empty... he did not mention that he had over a \$1,000 in the other account. I offered to go get him because he was allegedly in such distress.

When I spoke with Vicky tonight I was on my way back to the Carthage home. Arthur called me while I was on the road and asked me to come back here to the Winston Salem house. He said he wanted to be honest with me... but wanted to tell me everything face to face. I said I would come back here, but insisted that he start telling me while I was on the phone driving.... that is when he told me that he has been paid under the table by Chuck since at least last christmas...

and that he had sex with Samara when he was in Lubbock Texas.

Merry Christmas to me.

By the time I got back here I was exhausted... I tried to get a few hours sleep... but could not. To say that I feel sick really does not begin to cover how I feel ...

the house at 3748 - Vass Carthage Rd is not habitable. I said I would like to bring a member of the clergy, to see the Vass Carthage home and how I live.. and then come up and see this house and how Arthur is living... and to listen to what is going on, from Arthur and I . I said maybe I was not listening to Arthur's side of this and maybe an impartial person might help. Arthur said that he will not allow it, he became very angry, told me to get out of his house... said that he hated me, that I was a bitch, "who always stirs up trouble." Arthur will not allow me to have a key to this house... the power bill is in my name... the rent is paid from our joint account... I am his wife.

He has gone back to bed... I am leaving to go back to Vass Carthage.
